## MEMBERS

Members of C200 comprise an extraordinary group of women, whose vision and influence make them experts and role models across industry, culture, business discipline and geographic boundaries. C200 founders include trailblazing women in business, such as Christie Hefner, Katharine Graham, Judi Sheppard Missett, and Diane von Furstenberg.

To qualify for membership, the corporate candidate should be responsible for the full P&L of the parent company or subsidiary/division generating annual revenues of at least \$250 million (such as CEO, COO, General Manager, or Operating President). The entrepreneur candidate should be responsible for the profit and loss of the company, should be reporting a minimum of \$20 million in annual revenues, and be a company founder and/or a majority or controlling owner.

*C200 members collectively generate more than \$1.4 trillion in annual revenues.*

- *50% of active C200 members run businesses with revenues in excess of \$100 million.*
- *22% represent businesses with revenues in excess of \$500 million.*
